“AN EXECUTIVE ORDER CREATING AND CONSTITUTING THE INTEGRATED WATER,SANITATION AND HYGIENE (IwaSH) COUNCIL OF DIPLAHAN, ZAMBOANGA SIBUGAY”

WHEREAS, The iWaSH governance approach serves as a framework for achieving the targets set forth in the Sagana at Ligtas na Tubig Para Sa Lahat” (SALINTUBIG) and Assistance to Municipalities (AM) programs in the provision of potable water supply particularly among poor and waterless communities thru grant financing and enhancing capacities of Local Government Units (LGUs) and Water Service Providers (WSP), with the end goal of increasing access to water and sanitation services thru an integrated, equitable, and sustainable planning , implementation and management of iWaSH projects and programs;

WHEREAS, The Department of the Interior and Local Government (DILG) serve as oversight to the iWaSH Governance local implementation in all target site.

NOW THEREFORE, by virtue of the powers vested in me by the law, I, **ATTY. ERIC YAP PALMA**, Local Chief Executive of Diplahan, Zamboanga Sibugay, do hereby create and constitute the Integrated Water, Sanitation and Hygiene (iWaSH) Council of Diplahan,Zamboanga Sibugay.

Section II. Terms of Reference

1. Serve as oversight and policy making body on Integrated safe Water, Sanitation and Hygiene (iWaSH);
2. Formulate and implement the LGU iWaSH Sector Plan, where iWaSH targets and investments are included in the AIP, CDP and CLUP;
3. Formulate and pass local policies to support the promotion, advocacy, implementation and sustainability of iWaSH plans, projects and programs in the municipality;
4. Ensure that gender equality and women empowerment, CCA/DRR and PPP are integrated in iWaSH policies, plans, programs and projects;
5. Ensure integrity of local iWaSH governance to promote and protect the rights of local citizens to safe water, sanitation, hygiene i.e. establish mechanisms for local participation, feed backing, monitoring and reporting on iWaSH issues and concerns;
6. Identify areas for development and recommendations to enhance access to and provision of safe water, sanitation and hygiene services to target communities especially among women and girls; and
7. Ensure that performance of WUAs/WSPs are regularly evaluated in terms of providing quality , adequate, affordable and continuous safe water, sanitation and hygiene services.

Section III. Effectivity

This Executive Order shall take effect immediately and shall remain in force and effect until expressly revoke.
